

**Candid Brewing Co. Limited**  
**Membership Terms and Conditions**

**Principal Terms**

By joining Candid Brewing Co. Limited ("Candid Beer") as a member or by booking use of Candid Beer's facilities, including the Community Space, you indicate your acceptance of the following terms and conditions.

Your membership is personal to you and cannot be sold, transferred or assigned to another person.

Membership is only available for persons over the age of 18.

**Opening Times**

Access to Candid Beer's co-working space and the facilities available within it are provided on a reasonable endeavours basis within Candid Beer's regular opening hours:

Tuesday:	10am-7pm
Wednesday:	10am-7pm
Thursday:	10am-9pm
Friday:	10am-10.30pm
Saturday:	12.30pm-10.30pm

Candid Beer is not open on Sunday and Monday.

These opening times are subject to change and may vary from time to time. Any such changes or updates to opening hours will be published by Candid Beer on their website and/or by way of notices displayed at Candid Beer.

Should access or any facilities be unavailable Candid Beer shall endeavour to provide reasonable notice, but this may not always be possible. Where feasible, and at Candid Beer's sole discretion, Candid Beer shall make alternative arrangements.

Use of Candid Beer's upstairs co-working space is made available for members use only, and is offered on a first-come-first-served basis. Candid Beer does not guarantee space in either the upstairs co-working space, bottleshop/taproom, or Community Space.

You may invite and host guests within Candid Beer but meetings should take place in either the bottleshop/taproom, or pre-booked use of the Community Space, so as to preserve the upstairs co-working space for members use only.

**Fees and Payment**

A membership fee is due monthly in advance and payable by Direct Debit or another payment method offered from time to time by Candid Beer.

Details of the membership fee and payment date will be provided to you by Candid Beer upon receiving your membership application.

Candid Beer reserve the right to change the monthly price for membership, including the introduction of charging VAT, but will only do so after written notice of not less than 30 days. You may cancel your membership at any time up to the due date of any price change.

Membership ceases immediately with a monthly payment not being made.

You may cancel your membership at any time up to the due date of the next payment.

Candid Beer may cancel your membership at any time without notice if you breach Candid Beer's Terms and Conditions of Membership.

### **Bookings of rooms and spaces**

Bookings for rooms and spaces within Candid Beer, such as the Community Space, may be used by taken from time to time, subject to availability.

Community Space bookings are chargeable.

For members:

- Community Space bookings are charged with a 25% discount on advertised prices;
- Community Space bookings are billed monthly in arrears;
- There is no refund for cancellations within 24 hours of the booking;
- Bookings cancelled more than 24 hours but less than 7 days before the booking are charged and credited towards future bookings; and
- Bookings cancelled more than 7 days before the meeting are not charged.

Provisional Community Space bookings are not accepted.

### **Internet and computer/device usage**

Access to the public internet is provided for the lawful use of members and guests and must not be used for any activity which, in Candid Beer's sole opinion, is illegal, immoral, indecent or detrimental to the enjoyment of other members and/or guests.

The use of applications that automate requests to any websites is not permitted.

The hosting of services or applications designed to be accessed from outside of Candid Beer is not permitted without prior agreement.

Internet access may be provided to members and guests via the guest wireless service only.

You are responsible for securing your own computer data and protecting yourself from the impact of computer viruses, malware and malicious software. You must also take reasonable steps to protect Candid Beer, other members and/or guests from the impact of computer viruses, malware and malicious software.

Facilities and equipment provided within Candid Beer are intended for use by members and/or guests whilst in Candid Beer and may not be removed for use outside of Candid Beer.

### **Membership Benefits**

Benefits may be offered from time to time by Candid Beer. Any such benefits are at the sole discretion of Candid Beer and subject to availability.

Any such benefits made available to members only and should not be claimed or redeemed by or on behalf of guests or anyone else. Supply of refreshments is at the sole discretion of Candid Beer and subject to licensing legislation and regulations which is in force.

Candid Beer reserves the right to refuse supply or withdraw this benefit at anytime, and for whatever reason, without notice.

### **Privacy**

We reserve the right to monitor your usage of Candid Beer at any time, including your use of computer networks and the internet.

In becoming a member you consent to Candid Beer sending to you email correspondence regarding your membership, facilities at Candid Beer and other announcements regarding Candid Beer events. We will never sell or share your email address with third parties. You are able to opt out of receiving such email correspondence at any time.

This may include the use of CCTV in and/or around Candid Beer. CCTV is in operation to contribute to public safety and security, protecting both people and property, and due to licensing conditions.

You shall be responsible for any damage caused by you or any of your customers, clients or invitees to Candid Beer's premises or equipment whilst using Candid Beer's premises and shall indemnify Candid Beer against the cost of repair or replacement arising from any such damage.

Candid Beer's maximum liability to you is limited to membership fees already paid unless otherwise determined by the laws of England and Wales.

## **Miscellaneous Terms**

No relationship of landlord and tenant is created between Candid Brewing Co. Limited t/a Candid Beer and you by using Candid Beer's premises or by becoming member of Candid Beer.

Should any term of these terms and conditions be held to be invalid this will not affect the validity of the remaining membership terms and conditions.

Should there be any dispute in relation to these membership terms and conditions the laws and England and Wales will apply with the courts of England and Wales having jurisdiction over any such dispute.
